EXPERIENCE

Marymount is a private, comprehensive Catholic university founded by the Religious of the Sacred Heart of Mary in 1950. 3418 students, majority minority student body, 21% international students; 25% Pell grantees, 80% receive some form of financial support. The Department of Literature & Languages is part of the School of Design, Arts and Humanities, one of four schools in the university. In 2019-2020 AY, the Department employed 12 full-time faculty members and 10 part-time faculty members, and managed a three-track major (Literature, Writing, Media & Performance Studies) and the Secondary Education Licensure program (BA in English); minors in Literature, Writing, Media & Performance Studies, Gender & Society, French, Spanish; and housed the BA in Liberal Studies as well as the MA in English and Humanities, one of two graduate programs in the School of Design, Arts, and Humanities. In fall 2019, the Department generated 2,768 credit hours, 25% of the entire School of Design, Arts, and Humanities (now the College of Sciences and Humanities). In FY 2019-20, the Department budget was \$1.4 million in a School budget of \$6 million.

HIGHLIGHTED ACCOMPLISHMENTS

Vision and Curriculum Development: Led the creation of the Department of Literature & Languages' mission statement, as well as the School of Design, Arts, and Humanities' mission and vision statements. Our departmental statement was the first such on campus. Revised our major and minor to 39 and 18 credits, respectively. Led the development of a new and innovative B.A. program and minor in Digital Writing and Narrative Design, collaborating with faculty from Information Technology, Communication, History, Graphic and Media Design (launching Fall 2020 with pre-enrollment). Collaborated with faculty and staff in key positions to develop a prototype for a non-degree EAP program supporting writing and speaking skills for international graduate students. Initiated the development of a designated ESL section of Composition and a 1-credit writing lab, and liaised with colleagues in Academic Success Center and Advising to develop awareness of writing support. Developed four new courses in digital humanities, responding to curricular need: EN208 Digital Approaches to Literature, EN235 Digital and Nonlinear Storytelling, EN360 Book Histories/Book Futures, EN/HUM390 Digital Projects in the Humanities. Developed four new Online Synchronous and Asynchronous courses, responding to curricular need: EN101: Composition I, EN102: Composition II, EN231: Literature of the British Isles, EN340: Major Women Writers.

Budgeting and Hiring: In a tight budget climate, secured approval and oversaw successful searches for a new Lecturer position in Linguistics and a Postdoctoral Teaching Fellow to meet critical needs and improve retention. Notably increased the number of diverse faculty in the department. Worked with Dean to develop a zero-based budgeting practice. Invited to participate in the Transform MU initiative to restructure the budget for Library and Learning Services, with a mandate to find \$1 million in efficiencies and revenue generation.

Technology: Developed, maintained, and expanded robust departmental social media presence across Facebook, twitter, Instagram, YouTube, flickr, and LinkedIn to recruit students and promote Marymount's mission. Enhanced the program's alumni profiles and marketing materials with student text and video testimonials by following best practices in technology and communication. Worked with Admissions to develop and update marketing materials, educating new admissions staff about undergraduate career outcomes and opportunities. Utilized knowledge of and contacts in IT Support Services to advocate for thoughtfully updated technology in classroom environments; advised university administration on campus-wide LMS and online portfolio tools; spearheaded the campus-wide installation of WordPress on WRLC servers to facilitate classroom engagement and professional development of

students. Used technological literacy and university knowledge to work closely with Alumni Development and Advancement to identify gaps in alumni data. Spearheaded the development of a new program joining technology with storytelling, and developed four online courses in the department.

Partnerships: Enhanced our dual enrollment programs by developing 5 new courses and onboarding 3 new faculty, raising Departmental offerings to two-thirds of all dual enrollment classes available at Marymount. Facilitated Marymount's community partnerships with Arlington Economic Development, 1455 Literary Arts, the Veteran's Writing Project, and the Arlington Public Library through outreach and arranging campus events with student participation. In partnership with the Arlington Public Library, our Visiting Author Series brings internationally-recognized writers (Junot Diaz, Katherine Boo, Elizabeth Strout, Tim O'Brien, Julie Otsuka) to campus, so students in our First-Year Composition Program can meet the writers they study. Collaboration with Arlington Economic Development led to a well-attended public event on the economic and social value of theater, part of their "Return on Design" series of speaker panels. Enabled faculty development of durable relationships with 1455 Literary Arts, with import for our internship programs. Brought the 2015 Virginia Humanities Conference annual meeting to Marymount; organized and presided over the event, which saw nearly 100 participants from local community colleges, four-year colleges and universities, and cultural institutions from the DC metro area. Professionalized students by offering opportunities to help organize and oversee the event. This became the largest meeting of the VHC in the past decade or more.

Grants: Successfully pursued and administered a \$72,542 NEH Level 2 Digital Humanities Advancement grant with UVA co-investigator Dr. John O'Brien for *Literature in Context*, an open-access digital anthology; supported a successful NEH Summer Stipend. Mentored and supported faculty applying for tenure and promotion by providing letters of recommendation, advice on portfolio construction, and leading workshops on the rank and tenure process. Supported two successful faculty sabbatical grant applications and several internally-funded faculty development projects, as well as unsuccessful Fulbright applications and internally-funded development projects. Forge pathways for faculty to share their current research and creative work to the campus and wider community. Led 6 funded summer research projects with undergraduate and graduate students to develop *Literature in Context* contributions, opening new avenues for students to connect humanistic inquiry with digital skills development. Mentored three new faculty members, two in the department and one in Fine Art; helped professionalize Postdoctoral Teaching Fellows and new tenure-track faculty members by supporting their scholarly development and involvement in on-campus service opportunities connected to their goals and values.

Global Education: Led second- and third-year English lectures and *travaux dirigés* at the Institut Supérieur des Langues de Gabès, Tuisia, in March of 2012, including twenty-six hours of lecture and examination on American playwrights Tennessee Williams and Arthur Miller. Developed and led two iterations of new Global Classroom course in London, Chawton, and Bath. Supported the Global Classroom series by designating 1-2 Core EN classes per academic year as "Study Away."
